Second, After the payment of such funeral expenses and debts, I give, devise, and bequeath

First: Five hundred (500) Dollars to the Red Wing Seminary located at Red Wing, Minnesota.

Second: One hundred (100) Dollars to the Hanger Synod Minnesota.

Third: One hundred (100) Dollars to the Home Mission Society conducted in connection with said Hanger Synod.

Fourth: One hundred (100) Dollars to the Foreign Mission Society conducted in connection with said Hanger Synod.

Fifth: One hundred (100) Dollars to the orphans Home located at Berneford, South Dakota.

Sixth: One hundred (100) Dollars to the Home Alistan mission of India.

Seventh: Twelve hundred and fifty \$1250.00 Dollars to my daughter Lena Elvrum.

Eighth: Twelve hundred and fifty \$1250.00 Dollars to my daughter Bella Elvrum.

Ninth: The income from the balance of my estate real, personal and mixed, to my beloved wife Sara Elvrum, said portion of my estate after paying my just debts funeral expenses and bequests above mentioned to remain intact until the death of my beloved wife Sara Elvrum, and to then be divided in the following manner (to-wit:)

First: Four thousand (4000) Dollars to my son Ole P. Elvrum.

Second: The balance to be divided share and share alike between my children, to-wit, Bella Elvrum, Lena Elvrum and Ludwig P. Elvrum.

It is my wish that as long as my son Ole P. Elvrum properly cares for my beloved wife Sara Elvrum that he not be required to pay any interest on a \$4500 mortgage and note that I hold against him.

I, make, constitute and appoint Hans C. Sether to be Executor of this my Last Will and Testament.
