my lawful entry for permanent residence in the United States was at Blaine, Washington

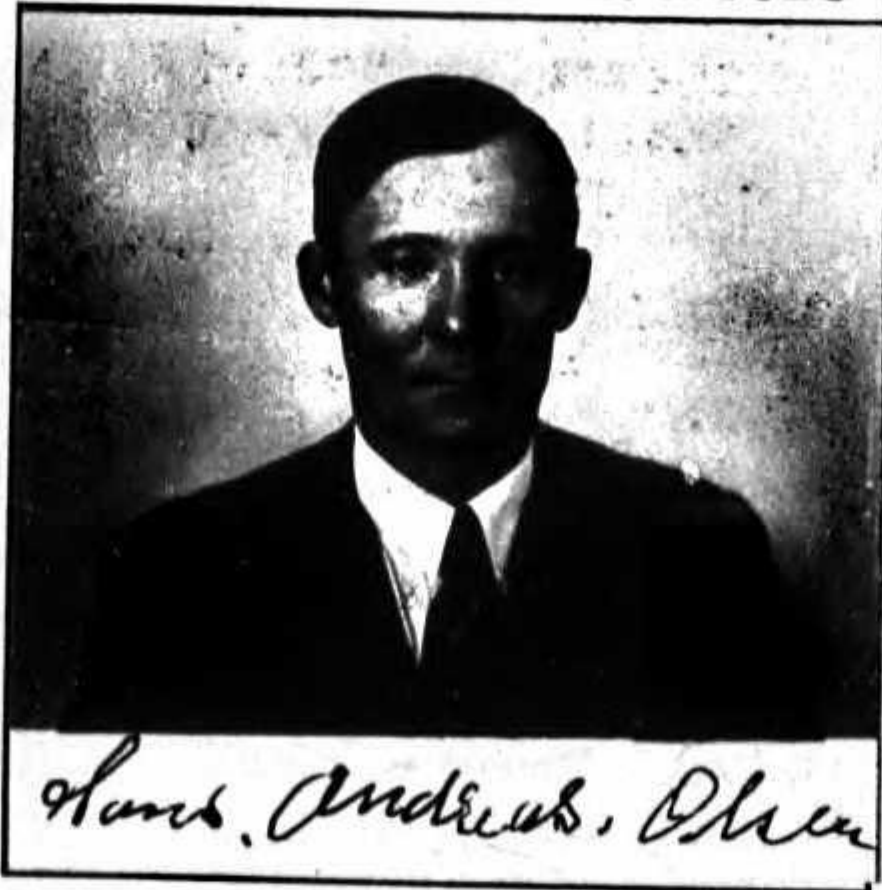
under the name of Hans Andreas Olsen, on March 9, 1928
